m 16^{th}}$ Oct 2023 in the name of the Hon'ble Governor of Manipur directing all relevant Deputy Commissioners and Superintendents of Police to implement the said direction of the Hon'ble Supreme Court of India.

That, in spite of the above stated orders, it has come to our knowledge that our residential house at New Lambulane 1st Street had been illegally intruded by unknown miscreants by breaking doors and windows thereby looted all my household properties estimated to be worth not less than 75+ Lakhsmoreover illegally occupied since the first week of March 2024. The matter came to light recently through a reliable source. However, the exact date and time of the incident could not be ascertained.

It is therefore, requested that you would be kind enough to look into the matter and take up necessary legal action.
