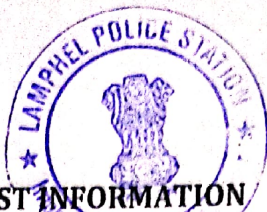

of Resident i.e. H/14-33 (Agape Homa) P.O. Lamphel P.O.
Lamphel, Imphal West District, Manipur and looted all prop-
ties in my house including, two wheels (Jupiter), Gear Cyc-
Television, Laptop, Printer, Desktop, all Beds, mattresses,
Aminrah, Gas stove, LPG cylinder (6 nos.) all our clothes &
jewellery, cash, sofa seats and many more. The approxi-
mate value of properties lost & damaged is estimated to be
about 30 lakhs. (Thirty Lakh).

I could not report the incident to my concerned police station
as well as in time due to the prevailing law and order
situation in the State.
