With due respect I have an honour to state a few lines for your kind consideration and necessary action.

That, Sir, on 4th May 2023 at around 1:00 PM, unknown miscreants comprising of 900-1000 people suspected to be Arant Lengol, Kangleipak Kanba Lip attacked our home at Lamphel, opposite of Kombirei, and looted our properties estimated to be around 50 lakhs.

I could not report the incident to my concerned Police station as well as in time due to the prevailing law and order situation in the state.

I, therefore, request your good office to kindly take up necessary action in this regard.
