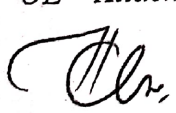

That on the 4th May 2023 at around 11am an unknown miscreants suspected to be Arambai Pengol Kangliepak :anka lup, Mietie upon numbering about 2000 attacked our house, House no- 31, Chingmeirong west, Pukhri Achouba Mapan, Vishal Mart opposite :mphal west, 795001, PO/PS : Lamphel and looted all the properties in my house. The appropriate value of if properties looted and destroyed is estimated to be about 30 lakhs.

I could not report the incident to my concerned Police station as well as in time due to the prevailing law and order situation in the State.

therefore request your good office to kindly take up necessary action in this regard.
