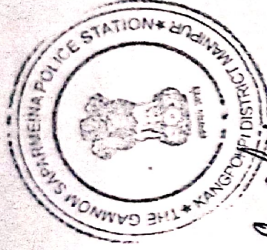

Sir, I the undersigned, submitted this report, that my newly constructed precast building (Patta No. 232 corresponding to patta No. 492/3181) at Langlei Housing complex, Imphal West, was burnt down on the night of 3rd May 2023 at around 8 pm by unknown miscreants from Meitei community. The entire building with 5-rooms with a stationary store were burnt to ashes and all the household goods were also looted by the same miscreants.

The value of the lost/damaged properties is estimated to be 40 lakhs approximately.
