



With due respect, I, the undersigned have the honour to state the following for your kind consideration and necessary action in your good hand office.

That, from the reliable sources on the 5th & 6th May, 2023 an unknown miscreants suspected to be Wangdei Leikai, Meitei Langol attacked my Resident Quarter No. D-14, Zone - IV, National Games Village, Imphal West District, Manipur destroyed everything and looted all my properties and left my quarter empty.

The appropriate value of my properties looted and destroyed is estimated to be about Rs. 24,34,000/-

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary action in this regard.
