That, on 4th May, 2023 at around 11:00 am
unknown miscreants suspected to be Arambai Tenggol,
Kangleipak Kanba Lup (KKL), Meitei Leepun numbering
about hundreds and thousand attacked our locality
i.e. National Games Village, Imphal West P.O. Lamphel
P.S. Lamphel, Manipur and looted all properties in
the house. The approximate value of properties
lost/damaged is estimated to be about 76,00,000/-
(Seventy six lakh) in my residence i.e. T/A-65
Zone-3, NGV, Imphal West.

I could not report the incident to my concerned
Police Station in time due to the prevailing law and order
situation of our state.

I, therefore request your good office to kindly take up
necessary action in this regard. Thanking you in anticipation.
