Sir,

With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That, on 4th May 2023 at around 3:00 pm, unknown miscreants suspected to be Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun numbering about 1000 suddenly attacked our locality i.e. Khongsai Veng, Imphal-East District, Manipur with deadly weapons and looted all properties etc from my house and also burnt down my house including all the important documents including 2(two) two wheeler vehicle 1(one) Yamaha bike and 1(one) activa. The approximate value of properties lost/damaged is estimated to be about 2.50 crores.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary action in this regard.

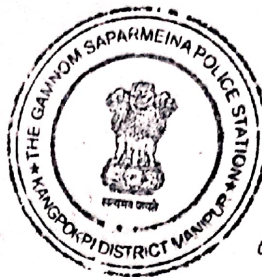
