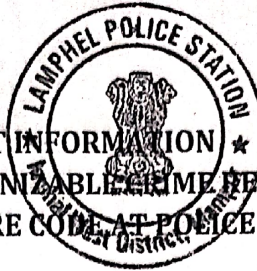

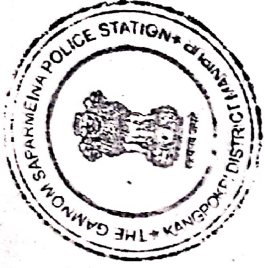

Sir,

With due respect, I have the honour to state few lines for your kind consideration and necessary action.

That, on 4th May 2023 at around 3:00 pm, unknown miscreants suspected to be Arambai Tengol, Kangleipak Kanba Lup, Meitei Leepun numbering about 1000 suddenly attacked our locality i.e. Khongsai Veng, Imphal-East District, Manipur with deadly weapons and looted all my properties from my house and destroyed the house and burnt down all the important documents including 1(one) two wheeler vehicle Activa and 1(one) Maruti Baleno b/regn No. MN06LB 6796. The approximate value of properties lost/damaged is estimated to be about 2.50 crores.

I could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary action in this regard.
