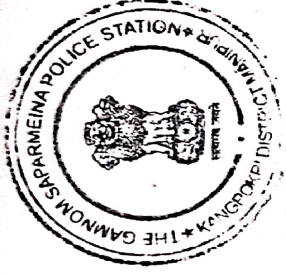

Sir,

With due respect and humble submission, I, Songthat Helen Haokip S/O (L) S. Mangchon Haokip of B-389, DGP Pool, Zone I, National Games Village, Imphal West, would like to file a complaint against on properties and House damaged on the 4<sup>th</sup> and 5<sup>th</sup> May, 2023.

My house and properties which is located at B-389, DGP Pool, Zone I, National Games Village, Imphal West have been vandalized and all properties including important personal file and documents as well as threatening of life, attempted murder by using machete and physically assaulted have been looted and destroyed by the majority Meitei/Meetei community. The approximate value of lost destroyed and looted properties is estimated to be about Rs.50 lakhs.

As the law and order situation is not good in the area, I could not complaint in my respective police station as well in time.

The following items of land and properties were destroyed and looted are as follows :

- 1). Households items and furniture's.
- 2). Others Movable and Immovable Assets.

I therefore kindly request you to take necessary action in this regards. Thanking You.
