With due regards, I the undersigned have the honour to state a few lines for your kind co-operation and needful action.

That, in the intervening night of 19/5/2023 & 20/5/2023, on this prevailing communal crisis some unknown miscreants enter at my Govt. Qtr. Located at Langol Housing complex, Qtr. No. A/67 by breaking main door and looted some household materials i.e. One Mattress, 3(Three) Vessel & 2(Two) Buckets, Glass, Utensils, Pots, three Gas Cylinder, one Stove, two Almirah, some cloths and also cash Rs. 50,000 (Fifty Thousand) only which was kept inside the locker during our absence. The approximate value is estimated about Rs. 1,00,000/- (One Lakh) only.
