Respected Sir,

As you are aware, a communal pogrom swept our state between May 03 to 07, 2023 leading to a severe loss of life and widespread destruction of personal and public properties. Entire villages including homes and places of worships were burnt and destroyed to the ground. Thousands of persons were forced to flee their homes and villages and are now evacuated. Amidst this violence and burning that spread through Manipur, some unknown persons burned down and destroyed the Ghari Meitei EFCl Church including my house and household things nearby the church on 5th May, 2023 (Friday afternoon).

This is a detailed description of the approximate monetary loss of our house that we suffered:
