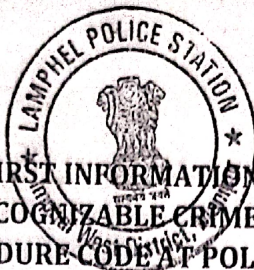

In the above fact and circumstance, I therefore requested that your good self my course of arrest of the miscreants involved in attacking and damaging my house and properties and take up on FIR against them as soon as possible for the interest for justice.
