I have the honour to state that, on the midnight of 4th May, 2023 at around 1:00 PM some unknown miscreants belonging to Meitei Youths Organization and members of Arambai Tenngol who are loyal group to the present Inner MP, Shri Leishemba Sanajaoba, world Meitei Council (WMC), Meitei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC) numbering about 1000 members carrying sophisticated weapons like AK rifles with vehicles forcefully entered in my private residence located at **National Games Village, Zone-I, Near Emanuel Church**. They looted all valuables and vandalized and burnt the house. The approximate value of lost and destroyed properties to be about 85 Lakhs.

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
