I the undersigned would like to report that on 5th May 2023 at around 8:00pm some unlawful valley based organisations suspected to be Arambam Tengol, Meitei Leepun, Kangleipak Kanba Lup (KKL), numbering around 1000 arms with sophisticated arms came into my quarter at Langol Housing Complex TYPE II/A-66 and looted all my household properties alongwith my car (TATA TIAGO ZX+) bearing Registration No. MN01AG 9344, Chassis No. MAT626350LKC12350 and Engine No. REVTRN08CZXX26028 which I have purchased on Car Loan from State Bank of India, Secretariat Branch, Imphal and cash of Rs 55000/- (fifty five thousand) only and gold ornaments. The estimate value of the properties looted is approximately Rs. 40,00,000/- (forty lakhs) only.

I therefore request you to kindly take up further legal actions against the miscreants by registering an FIR.
