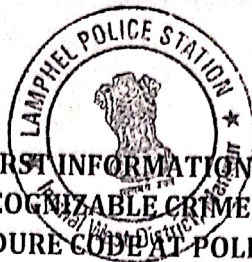

residence at Spring Villa, Langol, Imphal West and
vandalised and looted my household properties including
two vehicles i.e. an Autorickshaw B/R No. MN01Q4021
and TVS NTorque B/R No. MN01AM4025.

The approximate total cost of items is worth
around Rs 80,00,000 (Eighty Lakhs) only.

It is therefore requested to lodge FIR in
connection with this incident.
