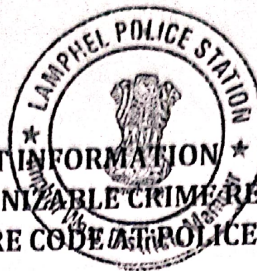

I have the honour to state that, on the midnight of 3rd May, 2023 at around 8:00 PM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Arambai Tenngol who are loyal group to the present Inner MP, Shri Leishemba Sanajaoba, world Meitei Council (WMC), Meitei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC) numbering about 1000 members carrying sophisticated weapons like AK rifles with vehicles forcefully entered in my rented residence located at **National Games Village, Zone-I, Near KBC Church**. They looted all valuables and vandalized the house. The approximate value of lost and destroyed properties to be about 8.5 Lakhs.

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.
