Subject : Complaint Report (FIR)

Sir,

I beg to state that, on 3rd May 2023, at around 7:00 pm, our locality National Games Village, Imphal west under Lamphel Police Station was attacked by thousands of violent mob belonging to the Meitei community with an intent to murder the Kukis residing in the area.

As a result of which, many houses and properties were destroyed and looted by the attackers.

My house NO. QTR No. Zone-4/A-2 was also attacked and all my properties including 2 four wheelers were damaged and my household properties looted and destroyed.

Properties looted and destroyed include the following:

1. Fortuner — Rs 35 lakhs
2. Honda City Amaze (Car) — Rs 6 lakhs
3. Kitchen items — Dining table with 6 chairs, kitchen almirah, Refrigerator, 4 gas cylinder, 3 gas stove, 5 dinner sets, utensils (includes everyday used kitchen items), 5 rice bags, 2 water filters = (Approx. 8 lakhs).
4. 2 washing machines = Rs (30 K)
5. 3 Syntex — Rs (25 K)
6. Flat TV — Rs (65 K)
7. 3 King size bed, 3 Queen size bed — Rs (1.5 lakhs)
8. 3 wooden and 5 steel almirah — Rs (2.5 lakhs)

- dressing table — Rs (50k)
- 25 Blankets — (Approx. 70k)
- 11. 5 Mattresses — (Approx. 55k)
- 12. Clothing items — (Approx. 6 lakhs)
- 13. Flower stand plus pots & flowers destroyed — (Approx. 50k)
- 14. 6 clothing racks — (Rs 25k)
- 15. Traditionally valuable items — (Approx. 1.5 lakhs)

Total estimate = Rs 64,20000 lakhs.

I, therefore request you to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at your station as I had fled my residence to save myself and my families from the rioters.
