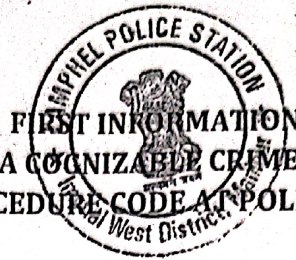

Sir,

I am to state that in the ensuing violence broke out in the state since 4<sup>th</sup> May 2023, I would like to file the report of damages caused to our church and its properties.

On 4<sup>th</sup> May 2023 at Lamphel Rongmei Baptist Church, RIMS Quarter Type II Lamphel, Imphal West around 01:45 PM an unruly mob consisting of about hundred numbers of unknown persons came in the campus of Lamphel Rongmei Baptist Church and set the church on fire including church office.

In the inferno the RBCC building of the church worth Rs. 7 Lakhs and church office worth Rs. 1 Lakh were completely gutted along with the following properties (*details of the properties are enclosed for your kind reference*):
