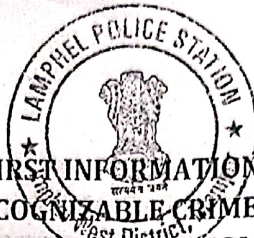

Subject: Complaint report (FIR)

Sir,

I beg to state that, on 3rd May 2023, at around 6:00 PM, our locality National Game Village, Imphal west under PO/PS Lamphel (Imphal west and falling under revenue of Imphal west) was attacked by attacked by thousands of violent mob belonging to the Meikai community with an intent to murder the Kukiis residing in the area.

As a result of which, many houses and properties were destroyed and burnt to the ground. My permanent house was also destroyed by the mob, most of my properties were burnt while the before were looted and vandalised.

Properties looted, burnt and destroyed include the following:

1. Immovable properties: Patta No. $\frac{18}{01A} / \frac{1}{3906}$ (New)

2. Movable properties:

- a) 4 wooden bed — 1 lakh
- b) 4 wooden almirah — 2 lakhs
- c) Sofa set, 1 center table, 2 side table — Rs 80,000
- d) Dining table + 6 wooden chair — Rs 55,000
- e) Colour TV (2) — Rs 60,000
- f) Computer table (4) — Rs 35,000
- g) 12 Plastic chair — Rs 15,000
- h) 4 Mattress — Rs 1 lakh
- i) Refrigerator — Rs 45,000
- j) Geyser 3 piece — Rs 60,000
- k) Chimney — Rs 25,000
- l) 4 LPG Cylinder — Rs 12,000

2 Activa - Rs 2 lakhs

n) Washing machine - Rs 20,000

o) 5 Syntex - Rs 36,000

p) 15 Blankets - Rs 22,500

q) Clothing items - Rs 1 lakh above

r) Utensils - Rs 1 lakh above

s) Important documents - Aadhaar Cards, Academic certificates etc.

Total loss of properties = Rs 12,65,500/-

t) Total estimated cost of land + building (2 storey building)
= Rs 15,00,00,000/-

Total Estimate - Rs 1,62,65,50,000/-

I, therefore request you to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at your station as I had fled from my residence to save myself and my families from the rioters.
