Today i.e. 21/02/2024 at 4.30 pm a video clip went viral from one Facebook account namely "Deva Sharma". In the video clip which was updated on 20/02/2024, some unknown individuals forcefully conducted trial between two individuals (including a woman) after intimidating them and making both of them sink inside two tubs full with water. The unauthorised trial suspected to be conducted at the house of one Md Ajijur of Mayang Imphal Yangbi outraged the modesty of the unknown woman who was taking part in the trial.

Hence, a Suo-Motto case under FIR No. 4(2)2024 MIPS U/s 354/506/34 IPC has been registered for investigation.
