

Today i.e. 28/02/2024 at 11:40 am received a reliable information that on the same day at about 11:30 am one Hyundai i20 bearing registration No. NL07H/2029 driven by unknown driver plying from Mayang Imphal side towards Thoubal collided with a Honda Activa bearing registration No MN04D/8285 ridden by unknown rider which was also plying from the opposite direction along Irong Chesaba road near Saw Mill, Irong Chesaba Mayai Leikai due to rash or negligent driving on the parts of the unknown driver and rider of both the vehicles. As a result of which rider and pillion rider of the Honda Activa received injuries on their persons and evacuated to Hospital for Medical treatment. The two involved vehicles were also partly damaged.

So, a Suo-Motto case under **FIR No. 5(2)2024 MIPS U/s 279/338/427 IPC** has been registered for investigation.
