With due respect I wish to state that due to the present situation in Manipur, since 3rd May 2023. I had vacated my house along with my family members on 8th May, 2023 for our safety.

I came to know yesterday i.e. 26th January, 2024 that my house located in Old Lambulane near Science and Technology Office was ransacked and looted by Arambai Tenggol and Meitei miscreants in the month of January, 2024.

That the said dwelling house was vandalized and looted of all properties. The value of the house and properties looted are as given below:

- (1) Patta No. 8 (Ingkhol) Point 0267 and 0030.
- (2) Properties value Rs. 80,00,000/- (Rupees Eighty Lakhs) only.
- (3) Two wheeler Vehicle bearing registered No. MN 01V 3896.
- (1) Mr. Chhungkaw Inkhawn Church Old Lambulane, Properties value Rs. 25,00,000/-(Rupees Twenty five Lakhs) only.
- (2) Mrs. Lhinglam Haokip, Properties value Rs. 10,00,000/- (Rupees Ten Lakhs) only.
- (3) Mr. Lunmang Vaiphei, Properties value Rs. 15,00,000/- (Rupees Fifteen Lakhs) only.
- (4) Mr. Khamminlian, Properties value Rs. 2,00,000/- (Rupees Two Lakhs) only.

Further it was reported that my house was locked and proposed for locating displaced persons by Arambai Tenggol to which I strongly object.
