Subject – Report on crimes of **vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.**

Dear Sir,

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the **Any Kuki Tribe**, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under **The SC/ST (Prevention of Atrocities) Act, 1989.**

That, due to the prevailing ethnic crisis in and around Imphal, I left my rented house located at Zomi Villa, Kabo Leikai Nongpok, P.O. & P.S.- Porompat, District- Imphal East on the **4th of May, 2023** at around **6.00 PM**, it has come to our knowledge that our deserted house was attacked and looted by a Group of radical Meeitei/Meiteis on the **12th of September, 2023** at around **9:00 PM**.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about **Rs. 10,50,700/- (Rupees Ten Lakhs Fifty Thousand Seven Hundred) only.**

That, it may be reported here that the miscreants were shouting slogans like- **"KANGLEIPAK YAIPHARE"**; **"KUKI HATLO"**; **"HAO HATLO"**; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a **ZERO FIR**, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
