

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, I left my rented house located at Zomi Villa, Kabo Leikai Nongpok, P.O. & P.S.- Porompat, District- Imphal East on the 4th of May, 2023 at around 6.00 PM, it has come to our knowledge that our deserted house was attacked and looted by a Group of radical Meeitei/Meiteis on the 12th of September, 2023 at around 9:00 PM.

The criminals broke open my door, destroyed and looted every valuable property from my house/ premise's worth about Rs. 10,50,700/- (Rupees Ten Lakhs Fifty Thousand Seven Hundred) only.

That, it may be reported here that the miscreants were shouting slogans like-"KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities.

In the given circumstances, I humbly pray you to kindly register a ZERO FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report lately today.
