2. That on 4th May 2023 at 4 pm, a huge contingent of Armed radical/ Meitei, Arambai Tengol and Meitei leepun attack our rented house in the process looted and Vandalized properties.

3. That the above said criminals with there in humane activities have causes me grave mental agony. Notwithstanding the fact that, there unruly activities have made me great loss enormous wealth estimated to be Rs 27 Lakhs.

4. Fortunatly, me and my family narrowly escaped from these criminals who even tried to kill us.

Henceforth, we are taking refuge at Mongkot Khopi Village, Churachandpur.

I, therefore, request you to register on FIR and bring justice.
