Subject: Report

The outbreak of unrest/conflict in the state and particularly in the state capital Imphal in the early days of May, 2023 forced me and my wife to leave our home i.e, Dewlahland, Imphal East District and my place of posting to a more secured area as safety to life and property was uncertain.

Things were under control until on 19-01-2024 the main iron gate lock of my residence was broken by a couple of unidentified persons and made their way towards my house. The collapsible gate locks were also broken down by them. They further broke open all the locks in the ground floor as well as the first floor and started freely residing in the house. On complaining to the authorities, they (the intruders) were removed from the house on 22-01-2024 by the police and a lock was put at the gate. However, the entry doors of the house remain unlocked.

It is also worth noting that my residence is safe guarded by at about 7-8 foot stone wall surrounding the compound. On entering the compound the residence of my younger brother is on the left and mine on the right. Both of us reside within the same compound. The residence of my younger brother has been looted several times in the past and FIR has been lodged accordingly at Imphal Police station.

On 27-01-2024, I received an information that on 24-01-2024 @ 9:30 pm some unknown armed persons came in a couple of vehicles and again broke the main gate lock and made their way to my house and started emptying all the household items one after the other and loaded them into their vehicles. After the vehicle made several rounds with the stolen goods the unknown armed persons left. I was also informed that none of the locality people interfere fearing as the looters were armed.

The incident cannot be communicated immediately with the police as I got the information days later and secondly, the estimated cost of the household items could not be ascertained as no one was willing to go inside the house to take a look or to take photographs till date due to fear of the armed miscreants warnings. I have a firm belief that those armed looters would have completely ransacked and taken away everything.

However, taken into consideration several decades of living in the furnished house, it should be in no way less than Rs. 1(one) crore, if not more. The household contains not only the daily modern gadgets and others but inheritance items from forefathers, important documents, sentimental value items etc.

in this matter, I would be grateful if the stolen items are recovered and lawfully handed over to me and the armed persons involved/participating in the activities are caught and produced before the law.
