I, Tinneichong Touthang W/o Lunkhohao Haokip would like to submit a complaint regarding and incident of vandalisation and looting of my shop which is registered under my proprietorship in KBC Shoping Complex, Shop named under "Good Faith Varity Store" Registration under IMC. Shop licence No. IMC/225/26/18 Dewlahland, Imphal East, Manipur. On 07.05.2023, we left our residence at Imphal East and took a flight from Imphal Airport and fled to Guwahati Airport on 07.05.2023. However, as per my knowledge there was no incident of looting at the above mentioned shop until 7th of May, 2023.

Recently on 16th of January, 2024 I have learnt that, all my property in the above mentioned shop was vandalized and looted completely somewhere in the month of June, 2023 by miscreants suspected to be from Meitei community. It is also learnt that, the keys of the above mentioned property/shop is in illegal possession of above mentioned miscreants since then.

It is duly submitted to you that due to this incident I lost hard earned property worth approximately Rs. 70,00,000/- (Seventy Lakhs only). Due to this incident I also suffered from mental agony and stress. In light of the above-mentioned series of incident, I request your good office to kindly register and FIR in interest of Justice.
