

I have the honour to report that on 07/02/2024 at around 06.30 pm, my Honda Activa 3G, Trance Blue in colour, bearing Regn. No. MN01AD3606 having Engine No. JF50ET6026848 and Chassis No. ME4JF509LGT026873 which is registered in the name of my father namely Ayekpam Ranjit Singh S/o Late. A. Rashi Singh of Singjamei Wangma Kshetri Leikai has been found stolen away by some unknown miscreant(s) while being kept parked under lock and key at Moirangkhom Kabui Khul near the Imphal River and could not trace out till date. The cost of the stolen Honda Activa 3G, is Rs. 30,000/- (Thirty thousand) approximately.
