2. That on 4th may 2023 at 10 am a large number of arms radical meitei Arambai Tenggol and Meitei Leepun attacked my Rent house.

3. That the above said criminal with their inhumane activities have caused me grave mental agony. Not withstanding the fact that, their unruly activities have made me loss enormous wealth estimated be Rs.5.7 Lakhs only.

4. Fortunately, I could narrowly escaped from those criminal who even attempt to kill me.

Henceforth, I am taking refuge at N.Songlung village, Kangpokpi District.

So, I could not make the said report on time due to the present situation which unable me to do the report

I, therefore, request you to register an FIR and bring justice.
