Today i.e. 12th February, 2024 at around 15:30 hrs, huge numbers of armed miscreants suspected to be Arambai Tengol numbering around 300 (Three hundred personnel approximately came by light vehicles likes Gypsy, Bolero, Thar, DI tata etc, and forcibly entered from the Indoor stadium southern gate of Khuman Lampak sports complex and also from northern gate of the 9th IRB (Mahila Battalion) Bn. Hq. Khuman Lampak Imphal. They broke the door and lock of arms and ammunition Kote room door of 2nd IRB Rear Head Quarter located inside the office building of the 9th IRB(Mahila Battalion) located inside Khuman Lampak sports complex by using iron tools and Bid hammer and started searching for weapons and ammunition . As there was no Arms and ammunition kept inside the room, no arms and ammunition have been taken by the armed youths, however empty cases of ammunitions which were collected during the Annual Range Classification Firing, 2022 numbering around 1164 and which was kept inside the room for replenishment and other formalities have been forcibly taken away by them.

Furthers, the armed youth suspected to be Arambai Tengol vandalized table, chair and bed of RHQ, 2nd IRB and also broke the store room of MT where tyres and lubricants items are kept. However no items from there have been taken / looted by them as they claimed that they were searching for arms and ammunition only.

So, I therefore request you kindly to look into the matter and take actions which are legally acceptable and also to kindly recover the lost government items at the earliest.
