

Sir,

With due respect, I have the honour to state the following few lines before you for your kind consideration and necessary action.

That, due to the violence in Imphal and adjoining areas, I have left my home and locality to safety place by locking my house and gate.

That, on dated 28th January, 2024 at around 10:00 am, it has come to my knowledge that, miscreants belonging to Meitei community in the name of Arambai Tenggol have enter into my house by breaking the gate and house door. The miscreants have looted all my household properties like Furniture, Kitchen and Utensil items, Electronic gadgets, Clothing and Garments, Gold and other valuable items. They have also looted my pharmacy store containing medicines, Go down containing medicines. Besides, the miscreants have illegally occupied and settle at my house without my consent.

The Total amount of looted and lost properties are estimated at Rs 60,00,000/- (Rupees Sixty lakhs) approx.

The incident could not be reported to my concern PS timely due to insecurity of our lives and volatile situation of the area.

I, therefore request you to kindly take up necessary action in this regard.
