

Subject: Complaint Report

Sir,

I beg to state that as a result of the ethnic cleansing pogrom that started on May 04<sup>th</sup> 2023, at around 02:00 pm wherein thousands of violent mob belonging to the dominant Meitei Community with an intent to murder the Kukis residing in Imphal area, set out to torch marched down to D.M. road and attacked the Kuki Christian Church, Dewlahland, Imphal falling under Imphal Police Station, Imphal East District - 795001.

That, as a result of the attack, and fearing for my safety, I had to flee from my quarter provided by the Kuki Christian Church and thereafter had to seek shelter at 2<sup>nd</sup> MR Camp and consequently had to escape Imphal. Having been left abandoned for over 8 months now, my quarter, which had remained intact and untouched in the beginning is now also subject to destruction and loot. Below are the properties being either damaged, vandalised or looted:

- (a) Furniture: Bed 5 nos., Wardrobe 3 no. Gas box 1 no.
- (b) Kitchen items: Gas Stove, all kitchen utensils
- (c) Electronics: Laptop, printer, induction, water pump(tulu), 2nos of Refrigerator, 2nos of washing machine
- (d) Clothing: All formal and casual wears of 3men, 4women and 3kids and 40 piece of blankets.
- (e) Books: One personal library
- (f) Food grains: 4 quintals of rice
- (g) Furniture: 3 sofa set, 6 Almirahs, 5 tables, 5 bed with mattresses, 10 chairs, 1 TV Box, 10 handicrafts chair
- (h) Traditional: 3 no. of bead, 30 nos of Traditional Shawls, 150 nos of wrap.
- (i) Others: 2 kids bike, Three nos of 1000 lts Sintax, sewing machine.
- (j) Cash: 45,000.00 (Forty five thousand only)
- (k) WAGON R LXI Car bearing No.MN03P5664

Total loss of property at my residence would be above Rs 35,00,000.00 ( Rupees Thirtyfive lakhs only)

I, therefore urge you to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the Interest of justice. I hereby lodge my complaint at your station as I had fled from my quarter to save myself from the rioters.
