

I **Satminthang Hangshing S/o Late Lalpao Hangshing R/O Dewlahang, Kangpokpi, Imphal East** Sub-Division, Kabo Leikai near Kids High School, Imphal East Manipur 795005 would like to report that my house Ground Floor has been looted by unknown miscreant due to the Ethnic Crisis of the two communities i.e. between Meitei and Kuki which was started on 3rd May 2023.

As a result, my house was abandoned and left to take shelter at 2nd MR Campus on 4th May 2023. The house has been looted on 30th January 2024.

The details of properties looted are listed as below:

1. **Immovable properties like house having G+3 storey building where I reside in the Ground Floor.**
2. **Movable properties:**
 - a) 1 Samsung QLED TV 55cm
 - b) 3 Almirah
 - c) 4bed(2platform bed, 1bedbox and 1wooden bed)
 - d) Traditional Shawls and Clothes including kids clothes worth 5lakhs
 - e) 1Gas stove, 5 Cylinder
 - f) 2Sofa Set, 1table, 1dressing table
 - g) 2 Geyser, 2water motor
 - h) 1samsung Font load washing machine
 - i) 1 Refrigerator Double door Samsung
 - j) 1 King size 6inch mattress and 15 blankets, 10 bed sheets
 - k) 3 Seater wooden swing from Hatil company
 - l) Utensils and Kitchen items.

Total Value of properties I left would be 5Crore.

Therefore, I would like to request you to kindly lodge FIR against my lost properties and investigate the same.
