On 16/03/2024 at@ 4:30 pm some unknown persons numbering about 14/15 persons who came in three different vehicle Gypsies at my oil pump "Yumnam and Son's Oil Pump" situated at Sekmaijin Hangoon assaulted one oil pump worker with intent to kill him. They damaged some valuable properties of the Oil Pump including counter wind shield glass. POS Machine issued by IOC was also partly damaged. In addition to this, the CCTV Cameras of the oil pump were also broken and then looted the Hard Disc/Mother Board of the CCTV and left the place by driving their vehicles. The merciless acts of the culprits caused grievous injury to the innocent oil pump worker and he was evacuated to hospital for medical treatment.

It is, therefore, requested kindly to take up necessary legal action as per law against them at the earliest.
