



Subject: - Report.

Sir,

I have the honour to state that today i.e. 18/02/2024 at about 09:00 am, received a reliable information about the presence of some active cadres of KCP an outlawed banned organization in and around Khuman Palli area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meitei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW, rushed to the said area and conducted frisking and checking at Khuman Palli Stadium road near Car Wash. During that one Honda I-vtec car white in colour without regd. no. coming in a very suspicious manner from Dingku Road towards our frisking zone was stopped for checking at the spot. On checking the said vehicle, one person along with a side bag black in colour was found driving the said car and was detained for spot checking and verification. On checking his side bag black in coloured:- (i) one wallet black in colour containing one Aadhaar, (ii) 2 (two) mobile handsets i.e., (a) one POCO X5 mobile handset along with one Airtel SIM card (Ph. no. 8730040521 as disclosed by him) (b) one Realme C53 mobile handset along with one Jio SIM card (Ph. No. 6009659871 as disclosed by him) and (iii) A sum Rs. 73,100/- (rupees seventy three thousand and one hundred only) were recovered.

During spot verification, he identified himself as Leishangthem Naobi @ Yohen Meitei (31 yrs.) S/o. Leishangthem Inaotombi Meitei of Game Village Zone-II Punshi Leikai. On preliminary verification, he disclosed that he is an active cadre of KCP(Noyon) organisation and joined the said organisation in the year 2007 and he got basic military training for 45 days at Leipok, Myanmar and allotted army no. 379 of 17<sup>th</sup> batch and presently holding the rank of s/s Sergeant Major of KCP(Noyon) organisation. He further disclosed that presently he is working under the command of s/s Lieutenant Chairenlakpa from Wangoo and s/s Lieutenant Punshiba from Phubala of KCP(Noyon) organisation. He also disclosed that under the instruction of his commanders, he was involved in kidnapping of three persons (two Meitei Pangal from Kwakta and one Meitei from Moirang) from Phubala, BPR District on 14/02/2024 and after getting the ransom money they were released on 17/02/2024. He further disclosed that from the amount of ransom money his commanders gave him a sum of Rs. 73,100/- (the above recovered amount) for his personal used. On further questioning about the said recovered Honda I-vtec car white in colour without regd. no., he disclosed that the said vehicle was forcedly taken from the above mentioned abducted persons by them.

Hence, he was arrested at the spot at 10:00 am and the above mentioned recovered articles along with one Honda I-vtec car white in colour without regd. no. were seized at 10:20 am by observing formalities.

It is, therefore, the arrested person and seized articles are handed over to you for taking further necessary legal action against him.
