



Sub:- Request to investigate against the death of my husband,
Takhellambam Rakesh Singh.

Sir,

With due respect, I would like to request to your goodself to investigate properly against the death of my husband, Takhellambam Rakesh Singh in a very suspicious manner, which was found near Basketball ground of DMU Campus at around 2 pm of 17/02/2024.

I would like to bring to your kind attention that my husband was a businessman and on about last week of January, there was a threat on his life. I could hear my husband over the phone being threatened by someone with regarding his business dealings.

It is pertinent to inform that yesterday i.e. 17/02/2024 my husband went out to meet someone for his business dealing to give Rs. 20 lakhs and left his office at around 12.40 pm.

Furthermore, I would like to add that as per one CCTV footage, I could see one white K10 car being parked near the spot and the same is found in a suspicious manner and also a two-wheeler is seen going by near the spot.

I therefore, with folded hands would like to report to your good self to properly investigate by interrogating any suspected persons. I would also like to inform that my husband usually records all his calls and as such request to check-up all the call records for proper investigation.

Kindly, investigate the matter without any bias and take up proper legal actions.
