A compliant for taking up necessary legal action against the accused persons, Mr. Paolienial Haokip, MLA, 59-Saikot (ST) Assembly Constituency and Officer bearers of Indigenous Tribal Leaders Forum (ITLF) for criminal conspiracy, abetment of the people to create mob to vandalise and burnt down of the offices of the Deputy Commissioner and Superintendent of Police, Churachandpur, dishonour of National Flag and for promoting enmity between different groups.

Sir.

As a law-abiding citizen of India, I, the undersigned filed the present complaint against the accused persons for taking up necessary legal action and to punish them in accordance with law for their unlawful activities. The accused person No. (i) by using his social media platforms as a tool propagate misleading statements to the people so as to destabilise peace and disturb communal harmony by creating enmity among the communities and defame the State Government. The accused



intentionally made false propaganda/ misleading statements/ misrepresentations and instigate the general public against one community and state so as to continue and escalate the present violence in the State of Manipur. The accused number (ii) & (iii) also openly abet and instigate the public more particularly the Kuki-zo community to create mob and also to vandalise public properties. Their unlawful activities are a threat not only to the security of the State but also to the Nation. They are continuously feeding the general public and instigating them to prolong the present act of violence. They are using the innocent general public as a tool to meet their ends. They are the main instigator for creating enmity between the Meeties and Kuki Zo communities.

The accused person No. (i) made his false propaganda/ statements and instigated general public to act against one community and State by using his social networking page — Paolienlal Haokip@paolienlal https://twitter.com/paolienlal run and operated by himself. The accused No. (i) used his X (formerly Twitter) account as a platform to fuel further violence in the State of Manipur and to destabilise the Government by misleading and spreading false statement/ propaganda to his followers and general public/ common people. The accused No. (i) is continuously instigating and abetting the Kuki-zo public against the Meetei on various occasions by using his X account.

That one Head constable Siamlalpaul of Churachandpur Distirct Police was suspended from service vide Orders dated 15.2.2024 issued by the Superintendent of Churachandpur Distirct for his unlawful association with armed miscreants.

On 15th February, 2024, at Imphal which is within the jurisdiction of this Police Station, one of the posts of accused No. (i) with false propaganda was came to the knowledge of the complainant and the same is given herein below for easy reference –

"They gave away state security arms and ammunition, non suspended: they lead mobs to burn down Kuki colonies in Imphal, no action. A police personnel appeared in a viral video of Kuki volunteers and he got suspended? Is this a just state? Whoever supports an unjust state...."

Screenshots of the statements made by the accused person in his X (formerly Twitter) Account is enclosed as Annexure-A.

Thereafter, his words instigated and provoked the unprecedented large-scale violence in Churachandpur District on 15th February, 2024 which started at around 10:00 - 10:30 pm and ultimately resulted to vandalising Mini Secretariat, burning down of the Office of Deputy Commissioner, Churachandpur and Office of the Superintendent of Police, Churachandpur and dishonour of National Flag of India, by bringing down the national Flag hoisted at DC Office.

That it is a fact that present State Government is not adopting any kind of selective discrimination to Government employees based on communities whether they belong to Meeitei or Kuki community. Recently 7 (seven) personnel belong to Meetei community were suspended on Friday for negligence in duty following the looting of arms and ammunition by a mob from the 5th Battalion Manipur Rifles camp in Imphal East district on Tuesday, 13th February, 2023. The same is also reported widely in

many newspapers.

That the accused No. (ii) & (iii) also instigated and abetted on various occasion. On the suspension of the aforementioned Head constable, the ITLF issued Public Notices No. ITLF-PN-202466 dated 16.2.2024 for immediate cancellation of the suspension Order, also demanding the DC and SP of Churachandpur District to leave the Distirct within 24 hours. If they don't leave to close all Government offices of the Distirct. Further, another public notice No. ITLF-PN-202467 dated 17.2.2024 was also issued thereby notifying that all state government offices will be closed from Monday, 19th February, 2024. Such act of the ITLF is not only anti-national but also instigated and abetted to create further public mob to vandalise public properties. Moreover, it is an act of obstruction of public servant in performing their public functions and illegal act obstructing to the State Administration.

Copies of the Public Notices dated 16.2.2024 and dated 17.2.2024 are enclosed as Annexure-B & C respectively.

Although the accused person No. (i) though a Politician and MLA representing - 59 Saikul Assembly Constituency, he violates his oath of office as an MLA to keep the integrity of the State and Nation. He in collusion with ITLF and other Kuki separatist organisations is trying to disintegrate the State and the country. As the main cause of present violence is because of Government policy on war on drugs, public movement for implementation of NRC, the Kuki Narco terrorists started this violence. As such a serious investigation for his connection with narco terrorists and other anti-social elements is highly necessary. And as his social media account is spreading false and concocted stories not only to his followers but also to general public, the same needs to be freeze/ block immediately so as to enable to retore peace and normalcy in the State of Manipur.

On the other hand, the accused No. (ii) & (iii) under the banner of ITLF are misusing the general public especially the Kuki-zo communities by instigating and abetting them against other communities so as to disturb the peaceful co-existence of different communities within the State of Manipur. The accused No. (ii) & (iii) on various occasions is misleading the general public and to prolong the violence in the State.

In the facts and circumstances, strict legal action may be taken up against the above-named accused persons by registering a case for committing the offence under Section 107, 120-A, 141, 143, 146, 147, 148, 149, 153-A, 186, 188, 427, 435, 436, 500, 34 IPC, Section 2 of the Flag Code of India, Section 3 and 4 of the Prevention of Damage to Public Property Act and any other relevant sections so as to punish him in accordance with law.
