Respected Sir

I the undersigned, have the honor to draw your kind attention for taking up necessary action by considering the facts and circumstances as narrated herein below:

- 1. I am the mother of one Laishram Jogendro Singh who is the recorded pattadar and possessor of the paddy land (phourel class) under patta No.1218 (old) 96(new, covered by C.S Dag No.4020 measuring 1.28 acre of village No.76-Mayang Imphal, Imphal West Manipur and has been paying the land revenue tax of the said property till date and as such my son is the absolute owner and possessor of the said land.
- 2. My younger brother Laitonjam Bijoy approached the Ld.Revenue Tribunal by challenging the mutation orders of the abovementioned agricultural/paddy land, claiming the said land as his own land and the Ld. Tribunal was pleased to reject the illegal claim of Mr. Laitonjam Bijoy.
- 3. My son being the absolute owner and possessor of the said agricultural land has been carrying on his fish farm bussiness in the said land. However, the family of the Laitonjam Bijoy Singh with malafide intentions and as an act of vengeance for defeating in the court/ Tribunal started disturbing/ obstructing



the work of my son in the said land illegally and disturbing the peaceful atmosphere creating a law and order problem in that area. Accordingly, my son have filed a complaint dated 07.03.2024 in the OC. Mayang Imphal to take up necessary actions and for protection including life and property of my family and the concerned Police Officer warned them not to disturb my family and the said property. But inspite of warning from the police, the family of Laitonjam Bijoy continued to their illegal activities.

- 4. Having all the legal rights to take criminal and civil actions against the illegal trespasser's, my son, Laishram Jogendro approached the SDO, Wangoi for taking up appropriate actions against them and to protect the said land from illegal tresspassers. As Ultimately, SDO, Wangoi vide order dated 21.03.2024 issued the prohibitory order thereby prohibiting the Laitonjam Bijoy Singh, his family and his men from entering the said land.
- 5. During the said prohibitory direction, while my family was working in the said land on 23.03.2024, the family of the Laitonjam Bijoy Singh and his men started attacking us and the wife of Laitonjam Bijoy Singh namely Laitonjam Sovarani Devi and his four sons poured some unknown chemicals/acids on my body burning part of skins in severe conditions and I was treated at RKS PHC, Mayang Imphal and doctor has confirmed it as "burn with unknown chemical" through MLC 657.
- 6. The illegal criminal act of the Laitonjam Bijoy's Family amounts to grievous hurt, attempt to murder and acid attack which is a serious crime specially against a woman as already settled by the Hon'ble Supreme Court and requires to be taken stern action against the said accused persons immediately.

In view of the facts and circumstances narrated hereinabove, I therefore, humbly request your goodself to kindly take up immediate actions against those accused persons and any other accomplice in the said crime by registering an FIR (First Information Report).

Looking forward to a positive response from you, sir.
