Complaint against fabricated and concocted false claims over electronic media regarding Thangjing Laiphamlen and Thangjing Chingsong.

Sir,

I, the undersigned in representation 'Federation of Haomee' FoH, have to submit this complaint for necessary action.

That, the Zomi Students' Federation, (ZSF) General Headquarters in their press release under the caption 'Zogam - The Land of Christ' dated 15th February 2024 has made the following nefarious claim -Thangsing hills belong to the Zo people who will continue to exercise their Constitutional Right to Religion and will continue to erect whatever religious symbols their religious fervor drives them to. It is given that wherever people go for pilgrimages outside of their ambit, the act of such pilgrims erecting religious symbols does not make it their own. Similarly, Meiteis have gone on religious pilgrimages to the hills in the past, and the pilgrimages the Meiteis had undergone were only possible due to the goodwill of the land owners, and does not mean that the land nor the erected religious site belongs to the Meiteis.' Whereas, Shri Thenkhomang Haokip, Self-Styled Chief Ukha Loikha Village in his clarification dated 16thth February 2024 countering the press release of ZRF has made the false statement/claim that Historical THANGTING of Ukha- Loikhai Haokip Kuki Village is situated within 'HAOKIP RESERVED-1907' of Colonial Kuki Hills and that he is 'the owner and Chief of the 'Historical Site', no individual or Organization or NGO has the right to distort my inherited 'Land & Heritage' from my forefathers.' The Thangjing pilgrimage site and is an integral part of Moirang Kangleirol, which is protected as a sacred shrine under Section-4 of the Manipur Ancient and Historical Monuments and Archeological Sites & Remains Act, 1976 for an area of 4 Hectares (approx) located at Thangjing Hill range, vide Manipur Gazette Notification No. 376 date 14th November, 2022 and order dated 26th October, 2022 issued by the Commissioner (Arts & Culture), Govt, of Manipur. The present-day Thangjing Hill Range falls within the Churachandpur-Khoupum Protected Forests which was notified on 17-09-1966 vide notification no. 55/10/66-M(2) under Section 29 of the Indian Forest Act, 1927.
