Today i.e. 23/02/2024 at 09.30 PM, received information that on the same day at @ 09.25 PM one powerful bomb suspected to be IED was exploded inside the campus of DM University, Thangmeiband near the eastern side wall of AMSU (All Manipur Student Union) office. As a result of the blast two persons got injured and they were evacuated to Raj Medicity hospital, North AOC Imphal for medical treatment. Due to the blast impact some portions of the eastern side wall of AMSU office also damaged.

Hence, a suo-mottu case under FIR No. 97(02)2024 IPS u/s 307/326/427/120-B IPC, 3 Explosives Substance Act & 16 UA(P)Act has been registered against the unknown miscreants for investigation.
