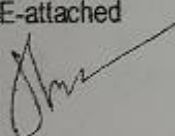

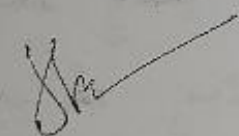
I have the honour to state that today 24th February at around 12:30 am some unknown armed persons numbering about 150 to 200 persons came inside the office and home of EEMA Shakti Sadan Shelter Home and broke inside and vandalized the entire office along with the residential floors of the Sadan Shakti Sadan home searched the entire building for Prakash, who was not at home at the time being while searching for him they entered all the rooms destroyed everything and took the safe locker of my daughter-in-law with them along with a vespa blue in color bearing Regd no. MN01AM3756 and My car (Creta Silver) bearing Regd no. AS01DL4202. with two phones inside.

I was at Haobam Marak Chingtham Leikai ~~and~~ when the incident occurred and rushed there as soon as I received a ^{call} ~~news~~ from my ~~good~~ daughter-in-law

When we arrived at the location we found all the armed persons in front of the road outside my office. ~~It is~~ We were forcefully dragged outside the car and beaten by them. and snatched the keys and left with the car. When we asked the residents how they were they also told us that the armed persons took all their cash and ID cards also.

I kindly request you to look into the matter and file a report.

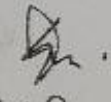
