I have the honour to state that on 28/03/2024 at about 2.15 am, a powerful bomb suspected to have been planted by some unknown persons blasted near the backside door of my Grocery cum Hardware shop located at Durgapur Karong along J.T road.

In that Grocery and hardware items valued about Rs.6 (six lakhs) approx. were badly damage. The brick wall and GCI roofing sheet of my shop were also badly damaged. The act of the unknown persons is attempting to my life and property.

It is, therefore, requested kindly to take up necessary legal action against the unknown miscreants.
