

Subject : Report.

Sir,

With due regards, I beg to state that today on 10/02/2024 at about 5.30 a.m received a reliable information that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at Gwarok Ching for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with COB Thoubal, 33 AR led by Addl. SP(Ops)/TBL assisted by OC/CDO-TBL under the supervision of Sr. SP/TBL rushed to the spot immediately and launched a massive operation at 6:00 a.m by using metal detectors. On searching at Gwarok Ching on the northern side of Gwarok temple the following articles i.e. (1) 5(five) Nos. 2 inch Mor Shells, (2) 5(five) Nos. of 36 Hand Grenade (can be used as explosive) without detonator (3) 1(one) No. of Tear Smoke Grenade, (4) 1(one) No. of Tear Smoke Shell (Normal), (5) 2(two) Nos. of Tear Smoke Shell Soft Nose, (SR), (6) 1(one) No. of 38 mm Cartridge with Rubber, (7) 1(one) No. of Country made Mor Shell, (8) 1(one) No. 9mm CMG with 2(two) Magazine bearing No. A4851, (9) 1(one) No. of 7.65 mm Pistol Browning's Patent with 1(one) Magazine, (10) 1(one) No. of Revolver (Country Made), (11) 1(one) No. of Air gun and (12) 1(one) No. of HTRF Walkie Talkie without antenna were found from the spot at 7:10 a.m. And further seized the aforesaid articles at 7:30 a.m. by observing necessary formalities. The massive searched Operation was conducted from 6:00 a.m to 8:00 a.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
