



I have the honour to state that today i.e. 19/02/2024 at around 04:00 pm. my aunty namely Mrs. Dinorjan Bibi aged around 50 yrs. W/o Md. Tamijur Rahaman of Yairipok Singa Mathak Leikai who came by riding a Captain Cycle towards Yairipok Bazar side along Yairipok Thoubal road was knock down by one unknown Car which was coming from same direction at Yairipok Bishnunaha near Paula Heroes School due to rash or negligent driving on the part of unknown car driver.
