



Today i.e. 20/02/2024 at 05:30 am received an information that on the same day at about 05:25 am one unknown two wheeler vehicle coming from Phouden Primary School Leirak towards Yairipok Thoubal road was knocked down by an unknown four wheeler vehicle coming from Thoubal side towards Yairipok side at Phouden Mamang Leikai near Phouden Primary School along Yairipok Thoubal road due to rash or negligence driving on the part of the unknown driver of the four wheeler vehicle and the said unknown four wheeler vehicle fled away from the spot after the incident. Resulting the rider of the two wheeler vehicle sustained injury on his person and evacuated to the Hospital for medical treatment. The two wheeler vehicle was also partly damaged.

Hence a sou-motto case under FIR No. 10(02)2024 YPK-PS u/s 279/338/427 IPC has been registered for investigation.
