Sir,

I have the honour to state that today i.e. 06/02/2024 at @ 3:00 pm received a reliable information about the presence of some members of valley base banned unlawful organisation in and around Thangal Bazar area for monitory demands to some businessmen and to do other prejudicial activities. On received of the above information, self along with SI. P. Siddhartha and ASI RK. Chinglensana Singh of City-PS rushed towards Prajatantra Galli, Thangal Bazar, Imphal and conducted frisking and checking. In that one unknown person came in a very suspicious manner towards the frisking and checking area. Due to his suspicious nature, he was detained and verified at the spot and he identified himself as one Maibam Arunkumar Singh 45 years of aged S/o Maibam Boro Singh of Khurai Ningthoubung Leikai, Imphal-East, Manipur. Further, he disclosed that he is an active member of RPF/PLA working under the command of one S/s Major Lamyamba @ Ambulance of RPF/PLA Finance Department. He also disclosed that as instructed by S/s Major Lamyamba @ Ambulance of RPF/PLA (Finance Department), he came to Khwai Bazar area including Paona Bazar and Thangal Bazar to collect Money from the businessmen. Earlier in the first week of February 2024, as instructed by the alleged S/s Major Lamyamba @ Ambulance of RPF/PLA, he gave many contact cards of RPF/PLA Finance Department to many businessmen located at Paona Bazar and Thangal Bazar, Imphal. On his body searched, found one wallet black in colour containing a sum of Rs. 2,200/- (500x2 & 100x2), one Aadhar Card in his name bearing Card No. 6750-3053-9634, one Motorola Rose Gold keypad handset bearing IMEI No. 355228502533134 & 355228502533142 containing one airtel sim card bearing Mobile Number 9362896124 and one piece of paper written as "**RPF/PLA Finance Department Lamyamba Please contact : 89743291929**". Later, on his instincts found one Honda DIO (Black & Orange in Colour) without any Regd. Number. Hence, a prima facie is well established against him. So, he was arrested at the spot at 4:00 pm and seized the above mentioned one wallet black in colour containing a sum of Rs. 2,200/- (500x2 & 100x2), one Aadhar Card in his name bearing Card No. 6750-3053-9634, one Motorola Rose Gold keypad handset bearing IMEI No. 355228502533134 & 355228502533142 containing one airtel sim card bearing Mobile Number 9362896124 and one piece of paper written as "**RPF/PLA Finance Department Lamyamba Please contact : 89743291929**" and one Honda DIO (Black & Orange Colour) without Regd. No. NIL by observing all the necessary formalities at 4:15 pm.

It is therefore requested to kindly take further necessary action.
