





The Following arms & ammunitions were recovered from the said foothills:-

1. 01 x 7.62mm AK -56 Assult Rifle
2. 01 x AK – 56 Assult Rifle Mag
3. 02 x 12 bore single Barrel Rifles
4. 10 x 7.62mm Live rounds


And the recovered items are hand over to Gamnom Saparmania Police Station .
