I have the honour to report that on 02/03/2024 at about 4:15 pm my grandfather namely Ibombi Takhellambam aged about 62 years S/O. (late) Tombi Singh of Yairipok Bemon Leikai who was crossing the road on foot along Yairipok Chondrakhong Road at near Yairipok Bemon Leikai Forest Office was knock down by one NV (scouter ~~in grey~~ in colour) without registration no. which was coming from Yairipok market towards Yairipok Khoirum side along Yairipok Chondrakhong road due to lack or negligent riding on the part of the said scouter.

As a result of which my grandfather sustain injuries on his person and evacuated to CHC, Yairipok for medical treatment. I could not report the matter in time as engaged in treatment of my grandfather.
