

Subject: Report on crimes of looting, vandalism of poultry house and the killing of Scheduled Tribes.

Sir,

With references to the above cited subject, I have the honor to report to you as follows;

I am a scheduled tribe belonging to the Any Kuki Tribe, which is a recognized tribe under the Constitution of India and a permanent resident of Kangchup Songlung Village, P.O.- Lamsang & P.S.- Gamnom Sapormenia, District-Kangpokpi, Manipur.

That, on the 5th June, 2023 at around 11:00 AM, a mob of armed Meetei/Meitei suspected to be members of Manipur Police Commandos, Arambal Tengool, Meitei Leepun along with other miscreants in and around the area of the said community attacked our village, in the process they have looted and vandalized my Poultry House that includes;

- 1) Poultry House-Rs.2,30,000/-
- 2) Drinker- Rs.30,000/-
- 3) Electric wiring & others-Rs.15,000/-
- 4) Solar Battery, plates & others-Rs.50,000/-
- 5) 2(Two) Sintex Water Tank 1000 ltrs-Rs.15,000/-

That, it may also be reported that the said criminal activities have caused grave mental agony and incurred huge loss which is estimated to be about Rs.3,40,000 (Rupees Three Lakhs Forty Thousand) Only.

That, the reason behind my late application is due to which we were at a remote area for months.

Therefore, I humbly pray you to kindly register a ZERO FIR, and book the perpetrators under the relevant laws of our Country. And for which act of kindness I shall always remain grateful to you. Thus, I am filing this application lately today.
